### POLICIES AND ACTION PROCEDURE

D2 The institution's admission policy requires that each student meet one of the following requirements:

- 1 Have successfully completed high school or its equivalent as evidenced by any of the elements in the following non-exclusive list
- 2 Copy of diploma copy of certificates
- 3 Copy of a transaction showing high school completion or a certificate of achievement etc.
- 4 Have evidence that verification of the foreign student's high school diploma has been carried out by an external agency that is qualified to translate documents into English and confirm the x equivalent academic equivalence to a United States high school diploma

#### D3 Leave of Absence Policy

A leave of absence must be requested in writing in advance, unless unforeseen circumstances prevent the student from doing so, in which case the academy will determine that the start date of the absence will be the first day or date on which the student didn't show up due to the circumstances, the leave will be granted only in extenuating circumstances such as, among others, an accident, a prolonged illness, the death of a family member, the minimum time allowed for an authorized absence is 5 consecutive calendar days and the maximum time allowed is 30 consecutive calendar days. Principals will review the student's request with the student, but not all requested permissions will be granted. The standard recording days scheduled in the student's contract will be adjusted for the same number of days taken. The student will not have additional charges for registration due to her permission. The graduation date scheduled in the contract will be adjusted in the enrollment contract and will be reviewed by the student and the academy principal. 


